State Private adoption agencies in New York are voluntary authorized adoption agencies approved by OCFS Children in foster care are in the legal care and custody, or the custody and guardianship\*, of the local DSS commissioner The local DSS may give responsibility for the care of the child to a voluntary authorized agency
