The Value of Homestead Exemptions in Georgia - Brief

In 2007, property tax reductions for state and local governments combined was over \$750 million due to homestead exemptions, an amount equal to about 74 percent of total property tax levies in the state and 122 percent of the tax on homesteaded property Table 1 shows the property tax ...
