Jun 04, 2019 · Rule 8(a) provides: “[a] pleading that states a claim for relief must contain: (1) a short and plain statement of the grounds for the court’s jurisdiction ; (2) a short and plain statement of the claim showing that the pleader is entitled to relief; and (3) a demand for the relief sought ”
