THE MANAGER AS CHANGE AGENT Managers, as the visible leaders of their units, take on the function of change agent This change agent role involves moving the trend or issue from challenge to stable routine This is accomplished in several ways: Mediating imposed change through adjusting patterns of practice, staffing, and administrative routines

2 MANAGER ADDRESSES - for each manager being changed, list the name and address as currently shown on ACC records and then give the new address for that manager If more space is needed, submit another Statement of Change form If the person is also a member, also list their name, address, and new address in the Member Addresses section

STATEMENT OF CHANGE OF REGISTERED AGENT, ...

A registered agent may sign and file a statement of change only to the address of the registered office without a signature from any officer, manager, partner, etc The form must also be signed by a corporate officer, LLC member or manager or general partner when a change of registered agent is being made
