Reporting Requirements • Online reporting is required (unless given permission for paper filing) using NAUPA standard format (templates available on website) • For any amount \$5 or greater, we require detailed information on the property owner such as: – Name, Last known address including zip code, and SSN or FEIN, if known • All unclaimed property, regardless of amount, is required
